DIRECTIONS TO MATCH SITE

From East or West: take I-70 to Exit 131 St. Charles Rd/Lake of the Woods Rd. Turn S onto St. Charles Rd (0.1 mile). Turn R onto I-70 Drive SE. Stay on I-70 Drive SE for 0.9 mile. CCSC is on the left.

From North or South: take highway 63 to the I-70 interchange. Merge onto I-70 East and drive to Exit 131 St. Charles Rd/Lake of the Woods Rd. Turn S onto St. Charles Rd (0.1 mile). Turn R onto I-70 Drive SE. Stay on I-70 Drive SE for 0.9 mile. CCSC is on the left.



Notice to Exhibitors

The safety of the dogs is of primary concern. By entering this match, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform safely.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Match Committee.

Entry fees will not be refunded if the match cannot be held or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

Bitches in season are not allowed to compete. Entry fees will not be refunded for bitches to come into season after entries close.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Match Committee, be asked to leave the match site. In such case, no refund of any fees paid will be made.

All dogs must be on leash or crated at all times except when in the ring or when preparing to be in the ring.

Exhibitors are responsible for cleaning up after their dogs at match site and all hotel, motel and campgrounds where they are staying while competing at this match.

Exhibitors are responsible for being at the ring gate when the judge calls their number. The judge need not wait for any dog holding up a class. Show Me Agility Club of Central Missouri has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.

Entries must be made on official AKC Entry Forms and must include the signed Agreement and Rules. Please include only AKC Titles on your entries.

Returned checks do not constitute a valid entry fee. There is a \$30 returned check fee.

Owners are responsible for errors in making out entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date. No refunds for duplicate entries.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

Dogs under 6 months of age are not permitted on the show grounds.

Show Me Agility Club of Central Missouri does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.
